

At this focus meeting, they did not want to discuss pipelines, only develop a list of projects. So, there was no opportunity to share the philosophy that SWA discussed at our last Board meeting—

- 1. It is preferred that their existing pipeline route is followed.
- 2. However, if the pipeline comes through Lebanon County, there should be no free ride for Williams.

- They should contribute to public safety (a new 911 dispatch center, which was also submitted for consideration at the meeting);
- b. They should contribute to preserving clean air, land and clean water.
- 3. While being tough on enforcement, Swatara Watershed Association should continue to be at the table with a voice to negotiate routes, clean water, public safety.....

There was a level of suspicion in the room, and questions were asked about whether the Conservation Fund would be providing any funding for projects, or if it all came from Williams. Initially, projects will be chosen by Williams. Unfunded projects will be turned over to the PA representatives for the Conservation Fund for consideration. Projects are being nominated in nine focus groups in counties where Williams will run through. They are not mandated to do this. They have funded projects in the past, but this is the first time this focus group is being tried, and the first time funding will occur prior to any possible construction. After the focus groups are finished, no other window will be afforded to nominate projects.

Funding will be awarded to projects that can be completed in 2015.

<u>Swatara Water Trail:</u> In September 2014, to test a new gas pipeline around Kenbrook, water was taken from the Swatara Creek using the Jonestown Boat Launch. Damage occurred to the Launch, and Mayor Tyler Longenecker is requiring the company to pay for repairs in addition to a promised donation to their Park fund. Water trucks pumped one million gallons of water from the Swatara Creek in two days. A water withdrawal permit is required if an average of 100,000+gallons per day are pumped over a 30-day period, or over 20,000 gpd if the water is

consumptive and transported out of the Swatara Watershed basin. SRBC is following up on the activity.

## July 2, 2014

After policing the site for litter and enjoying watermelon under the shade of the trees, the meeting was called to order along the Swatara Creek at the Water Works.

Tom Embich continues to do a stellar job managing the Swatara Watershed Park. Tom reported that:

1) Friday, July 11, at 8:30 AM, Jack Curry, PADEP is visiting the SWP to inspect the well; the cap needs to be removed per his request.

- 2) While iron is a little high, a Pure Test water sample passed inspection. A bill for \$78 was submitted for payment.
- 3) The purchase of a used Husqvarna LGT2554 mower was requested to maintain the park. The Hscvarna received good consumer ratings, and has a 54" deck. Cost is \$1500. Tom contributed an amount for the widow. **A motion passed to purchase the mower**.
- 4) The old Craftsman LT1000 mower, which was not starting well, not cutting well, and from at least two mower professionals, assessed that the mower would need major repairs to put it back into service. Two local repair shops estimated several weeks to get to our mower due to the backlog of work. A neighbor who has a Craftsman LT1000 in very good condition informed Tom that he would be willing to take a look at it since he worked as a mower service man for the Alger Farms in Palmyra. He found a broken support strut for the mower housing, a broken tension arm for the mower assembly, and damaged shaft mandrell. He was able to weld the two broken pieces, ordered several parts that should be replaced to put the mower into workable, as a back-up or for mowing the rough areas of the park that will damage the new mower. At this point, he has donated all his time in repairing the Craftsman, except for a nominal cost for the welding repairs, which Tom personally paid.
- 5) Per Tom, Forester, Andy Brought reported that the main invasive tree species we have is the Ailanthus, or "Tree of Heaven", but we have some extensive multiflora rose, oriental bittersweet (*Celastrus*), and a couple of varieties of bush honeysuckle and some Autumn Olive. We need to be careful with control of the "Tree of Heaven" because we also have good growths of Staghorn Sumac and young Black Walnut, which are often mistaken for the invasive "Tree of Heaven".

Tom will mark those plants for control or removal that he doesn't get to personally. The oriental bittersweet can choke mature trees, and is more of a threat than poison ivy, mile-a-minute and other vines; the shrubby growth that needs control is the multiflora rose, but several sites of it are heavily infected by both the rose leaf-roller and Japanese beetles, which both act as biological control for the rose.

Andy's further recommendations to maintain or improve forest health:

- Keep an eye out for heavy bark peeling from woodpeckers on the ash you have on the property. This is an important indicator when trying to identify Emerald Ash Borer presence and damage. The occurrence of epicormic branches is another useful indicator for EAB presence. It's only a matter of time until you will start to see EAB damage and mortality, and it happens quick.
- 2. Control non-native invasives such as mile-a-minute, tree of heaven, and oriental bittersweet. Poison ivy and grape vine should also be controlled when they are causing serious health issues to mature trees. We spoke about using the "cut stump" herbicide

treatment on these vines, so they don't sprout back. Use whatever concentration the label calls for on a cut stump treatment.

- 3. Promote the pin oak. Because oak provides great food for wildlife, I would recommend releasing them when you can to get them more sun light and growing space. This may entail cutting a few small silver maple, ash, and boxelder to help the pin oak survive and become a mature tree.
- 4. Native tree species I noticed on the property include: American sycamore, pin oak, northern red oak, white oak, silver maple, red maple, green ash, hickory, river birch, staghorn sumac, tulip poplar, eastern red cedar, and eastern white pine. I may have missed one or two, but I think I got the bulk of them listed here.
- 5. Finally, I would recommend you remove the 4 dying/dead sycamore near camp site #2. These trees pose a serious safety risk to campers in that area.

## **Woodlands Management Policy**

The wooded areas of Swatara Watershed Park, 1929 Blacks Bridge Road, Annville, PA, East Hanover Township, Lebanon County, offer thriving ecological systems consisting of a variety of plants and wildlife and should be protected and enhanced through effective planning and management.

Woodlands are significant in their ability to reduce surface erosion and slow rainwater runoff, to provide retention for wetland protection, help maintain groundwater supply, and along the Swatara Creek, and its tributaries, to provide a riparian buffer which cools the stream and enhances aquatic habitat. Woodlands also provide physical benefits such as screening of winds, unwelcome noise, wind-transported elements such as air pollutants and snow; visual barriers to unsightly areas; and wildlife habitat and bird nesting areas. Woodlands enhance and define recreation and scenic areas and often provide increased property values. The ecological values of woodlands are maximized when fragmentation and forest edge is minimized and larger blocks of woodlands are preserved.

The woodlands of SWP are to be protected to add to the scenic beauty and recreation opportunities of the Swatara watershed in addition to the ecologic benefits. By this management policy the Swatara Watershed Association and all park users are obligated to protect the woodlands by limiting tree removal to dead trees that have fallen and create a safety hazard, those in the right-of-way of the transecting power lines on the property, and others designated for management due to safety or hazard risk to users of the park or for control of invasive plant species. In addition, provision will be made to support reforestation via native species, riparian buffer plantings, trail construction, and wildlife habitat improvement. Vegetative buffers along streams are to be managed only by SWP staff in a manner which provides maximum stream

quality protection and nominal hindrance to park users. NO clear cutting or extensive tree or shrub removal shall occur unless directed by park management due to previously listed safety issues or for control of invasive species. NO invasive or non-native species of plant shall be deliberately planted within the park.

As partners with Swatara Watershed Association, PA Department of Conservation and Natural Resources (DCNR) Service Foresters, PA Fish & Boat Commission or other professional woodland foresters may be requested to assist with planning to conserve natural resources and open space. Foresters can develop plans for management of forested land commensurate with their use as recreational areas, educational areas, riparian buffers, and wildlife habitat areas.

- Chimney. Ann, Ben and Jo Ellen met with Bill Brajkovich, Capital Area Chimney Sweeps. A photo up the chimney showed that the passage is clear. Bill explained that the stone is coated with a heat retardant cement. The naturally flowing metal heat-o-later is constructed of heavy steel. Air is taken in near the floor on both sides of the fireplace. As the heat from the side of the steel rises, a natural draft, which exits the fireplace, and enters the room about 5' above the intakes, is created. Perhaps the bricks that the Park Rangers found came from the back side of the mantle.
  - Two options were suggested. One option is to repair the existing chimney and the other option is to place an enclosed stove in the fireplace. North Forge on Route 322 was suggested. Jo Ellen stopped there on Tuesday, and learned that it would cost \$5000-\$6000 for an insert, which includes installation. Several reasons make this option unrealistic: 1) Price; 2) The exhausts are to the rear of stoves, and the opening to the flue is in the front of the fireplace; 3) An Historical integrity breach; 4) The heat-o-lators take electricity, which we don't have; and 5) The stainless steel chimney liner rusts out and needs replaced about every 10 years. 6) Likewise, an iron stove rusts. The cement sealed chimney has lasted for 75 years.
  - Bill wants to remove the existing heat-o-lator, and replace it as well as recoat the inside of the chimney. To exercise due diligence, there was consensus to seek a second estimate.
    - Historical review: The Bordner Cabin is created in the Rustic style of architecture, which is defined by the National Park Service as structures built between 1916 1942 such as a log cabin that is so highly stylized in its attempt to be non-intrusive that it attracts the immediate attention of those who are accustomed to the simplicity and frequent sterility of contemporary architecture. It may be built of over-sized, rough-hewn logs and stones with its obviously intensive use of hand labor and its clear rejection of the regularity and symmetry of the industrial world, marking it as the work of another age, the product of an attitude far removed from our own. Perhaps for the first time in the

history of American architecture, a building became an accessory to nature... Early pioneer and regional building techniques were revived because it was thought that a structure employing native materials blended best with the environment...

- A survey of significant rustic structures is needed. Often rustic structures are too young (less than fifty years) to receive proper attention under the current criteria of the National Register of Historic Places. Each year a few disappear and a good many more are hopelessly altered by renovation or remodeling done without sensitivity to the original design. In this regard the authors can only concur with Ms. Wilson: "The rustic timber and stone buildings found in our national parks...represent an important irreplaceable architectural resource which should be used and conserved."


